Regional development and spatial planning are gaining more importance in the European context. Globalisation and Europeanization have led to a repositioning of European cities and regions from an exclusively national to an Europe-wide context of priorities, projects, administrative patterns and legislation.

But despite international planning processes and documents, as the European Spatial Development Perspectives (ESDP) and the Territorial Agenda, numerous INTERREG and ESPON projects make obvious that planning, with reference to urban and regional planning and development, is due to different cultural contexts differently understood in European countries.

Dependent on the particular perception of urban and regional planning, the French term aménagement du territoire, the German Raumordnung, the Dutch Ruimtelijke Ordening or the Spanish urbanismo do not necessarily share the same understanding or pursue compatible objectives, strategies and instruments. A better understanding of the cultural contexts influencing planning and the management of interregional development projects can enrich and stimulate cooperation processes. Furthermore, it can contribute to the economic and social cohesion of the European Union.

The International Symposium's intention is to explore and analyse the cultural background of planning and development in Europe. Therefore, the Symposium is focusing on cultural variety and cultural differences regarding the specific occurrence of urban and regional planning and development. The aim is to encourage the analysis of different perceptions and meanings of space, specific planning traditions and philosophies, different planning objectives, strategies and instruments, as well as various societal rules and values.
